3. Must be fair, reasonable and community minded
4. A member and the member's spouse may not serve on the Board at the same time
5. All Directors must be willing to set aside personal interests for the betterment of the community

- **Friday, July 11<sup>th</sup>**- All ballots must be received by 4:30pm at the offices of Owens & Associates
- **Tuesday, July 15<sup>th</sup>- Thursday, July 17<sup>th</sup>**- The counting of all received ballots by Owens & Associates
- **Saturday, July 19<sup>th</sup>**- Annual Meeting - New Board Members begin their term
